### ORDER

The Director, Scheduled Castes Development Department as per the letter read above had submitted proposal for Administrative Sanction for the continuing State Plan Schemes & Centrally Sponsored Schemes for the FY 2024-25 .

2. Government have examined the matter in detail. The component 'IEC Activities' (Information, Education and Communication Activities) under the Head of Account 2225-01-102-96 Assistance for Training, Employment and Human Resource Development and the component 'Tele Medicine and Infrastructure' under the Head of Account 2225-01-282-96 Health Care Scheme were not included in the Scheduled Caste Sub Plan (SCSP) for 2024-25. Hence, the amount recommended for 'IEC Activities' under the Head of Account 2225-01-102-96 has been added to the component TRACE under the same head of account in addition to the amount recommended therein, and the amount recommended for 'Tele Medicine and Infrastructure' under the Head of Account 2225-01-102-96 Health Care Scheme has been added to the component 'Treatment Grant & Sole income earner' under the same Head of Account.

3. Government have already released the amount resumed on 31/03/2024 from the PSTSB accounts, from the Budget Estimate for the FY 2024-25. The amount thus released and the bill amount in the

treasury queue at the end of the FY 2023-24 were deducted from the Budget Estimate for the current FY.

4. In the above circumstances, Government are pleased to accord Administrative Sanction for the following Continuing Schemes as detailed below:-
